# AMENDED AND RESTATED DECLARATION OF RESTRICTIVE COVENANTS NORTH GATE HOMEOWNERS ASSOCIATION

This AMENDMENT TO THE AMENDED AND RESTATED DECLARATION OF RESTRICTIVE COVENANTS FOR NORTH GATE HOMEOWNERS ASSOCIATION (this "Amendment") is executed to be effective as of the date set forth below by WEST TANGLEFOOT DEVELOPMENT, LTD (the "Declarant"), a Texas corporation.

#### **RECITALS**

WHEREAS, WEST TANGLEFOOT DEVELOPMENT, LTD, a Texas corporation ("Declarant"), filed for record that certain Declaration of Restrictive Covenants, recorded as Document 2015-023527 in the Official Public Records of Bell County, Texas (the "Restrictions"), then amended and restated as Document 2017-013493 in the Official Public Records of Bell County, Texas (the "Restated Restrictions") and made the same applicable to the Property more fully described therein,

AND WHEREAS, Section (48) of the Restated Restrictions provides in relevant part as follows:

"During the Development Period, Declarant, at Declarant's discretion, may alter the Restrictive Covenants, without the joinder of any other Lot Owner",

WHEREAS, Article II(11) of the Declaration creates a Development Period which lasts 25 years from the date the Declaration is recorded, and is still in effect,

WHEREAS, Declarant desires to modify the language of various Sections in the Restated Restrictions,

NOW, THEREFORE, in consideration of the foregoing, the Declarant hereby amends the Restated Restrictions for the above-referenced purposes as follows:

Section (22) is replaced in its entirety with this Section (22):

- (22) Exotic or Dangerous Animals. An "Exotic or Dangerous Animal" is an animal that may pose a safety or health threat to the Owners of the Subdivision, their guest, invitees, Customers or tenants, and includes:
  - (a) dog breeds of pit bull, rotweiler and Doberman pincer, regardless of whether the animal is purebred, a mixed breed or registered with the AKC or similar registration organizations;
  - (b) poisonous insects, amphibians, or reptiles;
  - (c) boa constrictors and other constrictor reptiles;
  - (d) swine
  - (e) animals considered "feral" or wild by nature except guinea pigs, hamsters and gerbils;

and

(f) alligators.

Additional breeds of animals may be added to the definition of Exotic or Dangerous Animals from time to time, as determined necessary by the Association Board members, at their sole discretion, and the Rules and Regulations will be amended to include such breed of animals.


